Employment and Social Development Canada (ESDC) may refuse applications that are incomplete or contain errors. We will contact you to request any mandatory information if it is missing from your form.

If your response exceeds the space allowable in the form, a separate document may be provided to add information to sections of the application, up to the maximum page count indicated in the applicant guide for the total response (with the portion in the form counting for one page). This document should specify the question number for each response. This document should include all wiring diagrams, figures, tables, etc. that cannot be included within the Expression of Interest form. Text should be 12 point font with normal margins.

If a closing date is posted, you must submit your Expression of Interest Form by that date. We will not accept expressions of interest received after the closing date.

Notice to Applicants

Attestation
